- 551:084 Investigation; Exclusion of witness from a hearing. A governmental Body that is investigating a matter may exclude a witness from a hearing during the examination of another witness in the investigation.

Should any final action, final decision or final vote be required in the opinion of the Board of Directors with regard to any matter considered in such closed or executive session, the final action, final decision, or final vote shall be in the open meeting covered by this notice upon the reconvening of the public meeting.
